The Association of Counseling Sexology and Sexual Wellness had an extremely successful year in the 2022-2023 timeframe. Dr. Frances McClain, as president of ACSSW during this time period, led the charge in continuing to work to promote ACSSW to division status, which is currently on-hold due to some restructuring withing ACA. Dr. McClain also established a BIPOC Task Force which worked tirelessly over the year accomplishing many goals, including identifying speakers for the 2023 ACSSW Webinar Series on BIPOC voices in sexuality, reviewing the current literature on BIPOC populations related to sexuality and sexual wellness, providing recommended areas of research for sexual wellness for BIPOC communities, and providing recommendations for the profession and for ACSSW on how to elevate BIPOC voices. Candidate Position Statements....

Due to the resignation of Robert Zeglin, ACSSW President, and transition of Shannon Shoemaker, President-Elect, into the office of ACSSW President, a secondary election is needed to replace the President-Elect for the 2023-24 year. Ballots have already been sent out to ACSSW membership. The election will be closed on Monday, September 25th. Below are the position statements of the two candidates for the President-Elect:



Robyn Flores

Position Statement: Hello! I am honored to be nominated for the position of President-Elect for ACSSW. If I am elected, I plan to serve as a voice of advocacy and leadership and as a collaborator with my colleagues and valued members. I am seeking to serve in this role to be able to lead, serve, and amplify the need for representation, equity, and advocacy within the field of counseling sexology and sexual wellness. I am a sex therapist and sexuality educator certified through the Sexual Health Alliance. I am also a doctoral candidate, in the dissertation phase, working on my Ph.D. in Counselor Education and Supervision from the University of the Cumberlands, a CAREP-accredited program. I earned my bachelor's degree from Texas A&M University and master's degree from Texas A&M University – Commerce. I currently co-teach two doctoral-level courses at the University of the Cumberlands, Ethics and Legal Issues in Counselor Education and Supervision as well as Neuroanatomy. I also co-teach a Counseling Adolescents masters-level course at the University of North Texas, specifically educating on sexual development and sexuality topics that come up with this age group. My research and advocacy interests revolve around exploring the perceptions of affirming counseling experiences for individuals who identify at the intersection of neurodivergence and erotic marginalization; demystifying erotic countertransference in the supervision space; and examining the effects and counselor experiences of cultural countertransference when working with erotically marginalized individuals and nonmonogamous relational dynamics. I am a Licensed Marriage and Family Therapist, caring for clients in Texas, Colorado, and Missouri. I am also licensed as a Licensed Professional Counselor and Approved Clinical Supervisor in Colorado. Through my service as President-Elect, I plan to support ACSSW's essential committees and leadership team by addressing needs in a proactive manner. Additionally, I want to work closely with the American Counseling Association and continue to advocate for sex and sexuality to become normalized, shame-free topics in the professional helping realm for counselors, supervisors, educators, supervisees, and our clients.



Laurie Bonjo

Position Statement: My name is Laurie Bonjo, and I am honored to have been nominated to serve as President-Elect of ACSSW. I currently serve as associate professor and program coordinator of the doctoral program in Counselor Education and Supervision at Southern Connecticut State University. For those of you who don't know me, I will share a little bit about the work I am currently doing at SCSU to support skill development in sexuality counseling among our students at SCSU. As a counselor educator, I have actively worked to promote sexuality as a central aspect of being human in all my classes. In addition to infusing my traditional courses with clinical practice around sex and sexuality, I also developed a master's level course focusing exclusively on sexuality counseling. In this course, students have opportunities to explore ways to support sexual wellness among heterosexual, cisgender clients as well as nonheterosexual and gender expansive clients across the lifespan. Students practice being in the role of the counselor when clients bring sexual thoughts, feelings, and experiences into session. In the context of sex positivity, we also discuss things like kink culture, the BDSM community, ethical nonmonogamy, applications with neurodivergent people and people with disabilities, and how to work with clients who are experiencing sexual dysfunction. This course has underscored the importance of skill development related to sexual wellness. Counselors-in-training need to learn to address client concerns that are positioned at the intersection of interpersonal and intrapersonal influences on sexual expression and identities inclusive of age, race, ethnicity, religion, sex, gender and gender expression, physical and mental health and abilities, and socioeconomic status. If elected to serve as President-elect of ACSSW. I will continue the work that has been established by our founding leaders to increase visibility of sexuality counseling and to support the infusion of sexuality counseling competency into counselor training. ACSSW is still a new organization that requires bold leadership with clear strategic planning directed at solidifying a voice and a presence in the broader counseling community. Like the Multicultural Competencies (MCCs) developed by the AMCD and the competencies developed by SAIGE for working with LGBTGEQIAP2S+ clients and those developed by SAIGE for working with transgender and gender-expansive clients, I envision ACSSW serving the counseling professions by generating competencies for sex-positive counseling. In addition to this effort, we will continue to centralize information and resources and provide our expertise through the efforts of the Education and Training committee. We will also continue to support the development of cutting-edge best practices through our Research and Scholarship committee. Through the efforts of our Social Justice and Advocacy Committee, we will reinforce the importance of sexology and sexual wellness in counseling and counselor education. To do all of this and also support membership and promotion, ACSSW needs leaders who are enthusiastic, magnetic, and visible. If elected to serve as president-elect of ACSSW, I will be a visible, passionate representative of our organization. I will advocate that CACREP support the inclusion of sexology curriculum in counseling programs. I will continue our ongoing work to be recognized as a division within ACA and I will engage with leaders of other divisions to increase opportunities for partnerships and collaboration. Perhaps most importantly, I will reinforce the inclusive culture of our organization so that our membership grows and increases representation and visibility of marginalized identities in our education, research, and advocacy.

Saying Good Bye to ACSSW Leaders Who Helped Lay the Foundation...



Dr. Tanisha Sapp became ACSSW Treasurer in the fall of 2020. She was the second person to hold that office in ACSSW history. During her tenure, Dr. Sapp assisted in the planning for the submission of the ACSSW application to become a division and submitted the proposed budget for the application. In 2021 she copresented for the ACSSW webinar series titled "Deconstructing Sex Education: The Whole Truth & Nothing But The Truth." Dr. Sapp co-chaired the BIPOC Task Force with Dr. Jenae Thompson. Dr. Sapp resigned her position as ACSSW Treasurer and Co-Chair of the BIPOC Task Force in June, 2023. ACSSW is indebted to Dr. Sapp for her contributions and we are especially grateful for her dedication to highlighting the importance of education/training and research in the area of sexuality in the BIPOC community.



Dr. Megan Speciale became the ACSSW Representative for ACA General Council in 2021. In July 2021 she co-presented at an ACSSW webinar on "Kinky Clients: Whipping Counselors into Shape." Dr. Speciale was also the Associate Editor for the *Journal of Counseling Sexology & Sexual Wellness: Research, Practice, and Education* and editor for the 2022 Special Issue. Dr. Speciale also assisted the ACSSW Executive Council in the planning and submission of the division application. She resigned her positions as Representative for ACA General Council and Associate Editor of the journal in July 2023. ACSSW is grateful for her work in the area of sexuality and assistance in moving ACSSW Itoward becoming a greater presence in the counseling field.



Farewell and Thank You to One of ACSSW's Co-Founders

It is with deep sadness we say goodbye to Dr. Robert (Rob) Zeglin who resigned from ACSSW in July. Dr. Zeglin has been with ACSSW since it was a seedling of an idea. From the beginning, Dr. Zeglin was a powerhouse. He demonstrated vigor and enthusiasm coupled with a firm belief that sexual health concerns ARE well within the competency realm of mental health counselors. Dr. Zeglin firmly believed that not only should counselors believe in themselves when approaching sexual issues but that it was an ethical imperative for the counseling profession to know how to approach sexual concerns in the counseling session.

Even before the birth of ACSSW, Dr. Zeglin dedicated his life to bridge the gap in sexuality and clinical training in counseling. Yet, his solo and co-written publications challenged the mental health field at large. In his co-written chapter, You Want to Do What? Treating Paraphilic Disorders Through a Sex Positive Framework, he challenged the Diagnostic and Statistical Manual of Mental Disorders (DSM 5-TR) interpretation of "normal" human sexual behavior, as well as, a solo article, Sexual Disorders in the DSM-5: Implications for Counselors, which again attempted to bridge the gap for counselors and competency related to sexual health. In another co-written chapter on ethics and sexual concerns in session, Nonmaleficence: A Terrible Safe Word But a Necessary Component of Counseling Ethics in Sex Positive Practice, he challenged mental health clinicians to consider their own competency by developing the first ethical decision making model addressing sexual health issues. Although there are too many to share here, his most notable work was a co-authored article on An Introduction to Proposed Human Sexuality Counseling Competencies. This piece is seminal to the mental health field, as there are no current published works that effectively address mental health counseling competencies and human sexuality. Each of these manuscripts can easily be considered pioneering works for the counseling profession around sexuality and sexual wellness.

As a co-founder, Dr. Zeglin utilized his expertise in mental health, counselor education, and governance to promote ACSSW as the authoritative voice on sexual health and wellness within the counseling profession. As he wrote in the ACSSW newsletter, "To this day, with the exception of sexual identity topics, there is no authoritative body within ACA or the wider counseling field to guide counselors, inform practice and research, or respond to public sexual health related issues and events." In doing so, he successfully authored the ACSSW bylaws which ensured the ethical and programmatic health of ACSSW. Those of us co-founders with little governing experience appreciated his knowledge and expertise on the topic of governance and felt assured under his mentorship. Moreover, Dr. Zeglin's vast research expertise made him the ideal person to create the first ever journal dedicated exclusively to sexual health and counseling (not to mention his phenomenal ability to take on such an arduous task as creating a journal from scratch). As a result, the <u>Journal of Counseling Sexology & Sexual Wellness</u> (JCSSW) Journal of Counseling Sexology & Sexual Wellness: Research, Practice, and Education was born and currently has over 50,000 downloads and an impact factor of 1.13!!!!

Among the many contributions of Dr. Zeglin, he will be most missed for his pragmatism, his belief in the counseling field's ability to incorporate sexual health training, his encouragement of counseling students to take leadership roles in ACSSW, and his friendship. We wish you the best Dr. Z and we know that you will continue to bridge the gap on behalf of all mental health professionals, but especially the counseling profession.

Committee Update: Social Justice & Advocacy

The following list of resources was developed by the Social Justice and Advocacy Committee in response to anti-LGBTQIA+ legislation being passed in the US. The ACLU is currently tracking 496 anti-LGBTQIA+ bills across 47 states, and according to The Human Rights Campaign 22 states have passed laws limiting gender affirming care for LGBTQIA+ individuals. These bills create an environment of uncertainty and extreme concern for counselors and the LGBTQIA+ community we serve, and we acknowledge the never-ending nature and complexity of these bills can be overwhelming for the LGBTQIA+ community. The Social Justice and Advocacy Committee hopes this list provides a start to assist counselors with tracking these types of legislation and resources to further support LGBTQIA+ clients.

BIPOC Representation Within the LGBTGEQIAP+ Community: It Matters!



Presented by Tamekia Bell, Ph.D., LCPC, ACS, NCC Friday, September 15, 2023 8:00am-10:00am PT / 10am- 12:00pm CT / 11:00am-1:00pm ET

This presentation will promote an intersectional framework (Chan et al, 2018) when working with LGBTGEQIAP+ clients from the BIPOC community. This approach acknowledges and affirms the ways in which gender identity and affectional orientation interacts with other privileged and marginalized aspects of the client's identity. A four stage framework (Astramovich & Scott, 2020) will be reviewed as a model to promote empowerment and provide a more holistic approach that addresses and affirms all of the clients identities. Additionally, the Socially Just and Culturally Responsive Counseling Leadership Model as well as other templates will be outlined that stress the responsibility of counselors and mental health professionals to proactively engage in anti-oppression, anti-racist activities. The specific action domains for advocating for BIPOC LGBTQIA + clients as described by Parker-Barnes, et al., 2022, will be reviewed.

editorial team requires that all authors follow the most current ACA
Code of Ethics and Standards of Practice. All manuscripts must
conform to standards detailed in the most recent edition of the APA
Publication Manual. The newsletter supports the use of genderneutral pronouns, including the singular "they." Manuscripts should
be concise, yet with enough detail to provide clarity.
